#### 1. Introduction

Activity Pole 4 'Quality Assurance and Validation' is dedicated to the quality assurance and evaluation of project methods, progress and outputs and is been led by UOC-NHMC (Partner 4), supported by all other Partners. This Pole aims to ensure a systematic monitoring and control of the project quality including the e-learning platform and training course. All Partners will be involved in this process as well as the learners and other potential beneficiaries of the project.

A comprehensive Quality Assurance Plan will document the quality expectations that the project must achieve and the methods through which such expectations will be met.

Built-in tools of the e-learning platform will assess the learning and training activities, allowing online feedback reporting.

It will also analyze and assess best practices related to training needs and skills matching the labor market and audience analysis.

A Validation Plan will be developed to validate the e-learning programme and an important task will be to investigate the recognition of the course and to issue certificates to the learners.

#### 2. Objectives

The O9: "Quality Assurance Plan & Report" will document the quality expectations that the project must achieve and the methods through which such expectations will be met. The Plan will be effective throughout the project lifetime and will be open to review whenever necessary. As part of this quality plan, each individual Activity Pole will be evaluated in cooperation with their leading partners, highlighting the quality aspects associated with the Activity Pole they are in charge of. The Quality Assurance Plan & Report will formulate also recommendations for assessment the quality of services for future e-learning courses development beyond project lifetime.

The "Evaluation of project methods" (A23) will standardize the assessment methodology while the A24 action will monitor and report the realization of Quality Assurance plan.

#### 3. Evaluation Methodology (A23)

Two types of evaluation with their relevant indicators will be used: *In-Itinere evaluation and Ex-post evaluation*. These two types of evaluation, under the use of specific tools such as questionnaires, records, web-platform forms with pre- and post-evaluation tests, computer generated and online scored tests, essays or power point presentations, will guarantee the Quality Assurance of the project as well as its further Impact.

#### In-Itinere evaluation

*In-itinere evaluation* will assess the <u>efficient implementation of the project.</u> It will be able to propose changes to the implementation methods in case of non-efficacy.

#### In-Itinere evaluation indicators

- > Extent of the information on projects outputs;
- Extent of the information on experiences in assessing input/output or cost/benefit relationships;
- Extent to which tasks and outputs listed in the work plan have been completed satisfactorily;
- Extent of the valorization of the image of project (number of web-site visitors, number of participants to conferences, seminars, meeting...);







- > Number of direct beneficiaries involved in the implementation phase;
- > Expectations of the direct beneficiaries

#### **Ex-post evaluation**

*Ex-post evaluation* will be carried out after the conclusion of the project, and, using the data collected and the experience gained from the project will check the reaching of the project specific objectives.

#### Ex-post evaluation indicators

- Frequency of information;
- Level of introduction of new approaches
- Level of the quality and performance of the community tools (which we defined as "usefulness");
- Level of project intervention impact (micro and macro impact) in the link between demand and supply generated by the BIOTALENT project
- > Other direct and indirect impacts produced by the project;
- > Level of sustainability of the dissemination and valorization strategy used.
